However, a number of long term animal studies and human epidemiology studies evaluating TiO₂ and workplace exposure show insufficient evidence for carcinogenic effects. EPA, NTP and OSHA do not designate TiO₂ as a carcinogen and ACGIH designates TiO₂ as A4 - not classifiable as a human carcinogen. TiO₂ is not present in this product as a dust and no airborne exposure is expected during application.

4. FIRST AID MEASURES
